- 1. The Islamic Republic of Afghanistan has received financing from the Asian Development Bank (ADB) toward the cost of Horticulture Value Chain Development Sector Project (HVCDSP). Part of this financing will be used for payments under the Contract named above. Bidding is open to bidders from eligible source countries of ADB.
- 2. The Ministry of Agriculture, Irrigation and Livestock ("the Purchaser") invites sealed bids from eligible bidders for the Procurement of Date Palm (the Goods). Delivery period is Sixty (60) days from the contract signing date.
- 3. Open competitive bidding National will be conducted in accordance with ADB's Single-Stage: One-Envelope bidding procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.
- 4. Only eligible Bidders with the following key qualifications should participate in this bidding:
- Submission of an audited balance sheet for the last three (3) years. Bidder's net worth calculated as the difference between total assets and total liabilities should be positive;
- . Minimum average annual turnover of AFN 88,800,000/- calculated as total payments received by the Bidder for contracts completed or in progress over the last three (3) years.
- · Participation as main supplier in at least one (1) contract that have been successfully or substantially completed within the last Eight (8) years, where the value of the Bidder's participation exceeds of an amount of AFN 35,520,000/- with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply).
