CONTRACT TERMS AND CONDITIONS

1. Definitions

- (a) "Contract" means the agreement entered into between the Client and the Service Provider, together with the Contract Documents referred to therein, including all attachments, appendixes, and all documents incorporated by reference therein.
- (b) "Contract Documents" means the documents listed in the Contract, including any amendments thereto.
- (c) "Contract Price" means the price payable to the Service Provider as specified in the Contract, subject to such additions and adjustments thereto pursuant to the Contract.
- (d) "Completion" means the fulfilment of the committed services by the Service Provider in accordance with the terms and conditions set forth in the Contract.
- (e) "Client" means the entity purchasing the Services.
- (f) "Services" means the services the Service Provider will perform as specified in the Scope of Services in Appendix A.
- (g) "Service Provider" means the natural person, private or government entity, or a combination of the above, whose bid to perform the Contract has been accepted by the Client and is named as such in the Contract.
- (h) "ADB" is the Asian Development Bank.

2. Applicable Law

The Contract shall be interpreted in accordance with the laws of the Islamic Republic of Afghanistan.

3. Language

All communications and documents related to the Contract shall be in English.

4. Assignment

Any assignment of this Contract or of any rights hereunder, in whole or in part without the prior written consent of the Client shall be void.

5. Fraud and Corruption

This Contract shall be covered by the provisions of ADB's Anticorruption Policy (1998, as amended to date) and Integrity Principles and Guidelines (2015, as amended from time to time) that requires Borrowers (including beneficiaries of ADB-financed activity), as well as Service Providers and Contractors under ADB-financed contracts, to observe the highest standard of ethics during the procurement and execution of such contracts.

6. Performance of the Services

The Service Provider shall carry out the Services with due diligence and efficiency and shall furnish to the Client such information related to the Services as the Client may from time to time reasonably request. The Service Provider shall at all times cooperate and coordinate with the Client with respect to the performance of the Services.

10. Taxes and Duties

The Service Provider shall be entirely responsible for all taxes, duties, license fees, etc., incurred until completion of the services to the 4% BRT.

11. Payment

Upon submission by Service Provider of claim and subsequent verification of the claim by Client, payment of the contract price shall be made in the following manner:

12. Resolution of Disputes

The Client and the Service Provider shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute between them under or in connection with the Contract. In the case of an unresolved dispute, the dispute shall be settled in accordance with the provisions of the Islamic Republic of Afghanistan _____ [arbitration law or rules of the Client's country].

13. Independent Service Provider

Nothing contained in this Contract shall be construed as establishing or creating the relationship of master and servant, employer and employee or principal and agent between the Client and the Service Provider, or his employees or agents or other persons engaged by the Service Provider to perform any of the services.

14. Intellectual Property Rights

Intellectual Property Rights: (a) The Service Provider shall indemnify the Client from and against any and all claims, liabilities, obligations, losses, damages, penalties, actions, judgments, suits, proceedings, demands, costs, expenses and disbursements of whatsoever nature that may be imposed on, incurred by or asserted against, the Client during or in connection with the Services by reason of: (i) infringement or alleged infringement by the Service provider of any patent or other protected right, or (ii) plagiarism or alleged plagiarism by the Service provider.

15. Failure to Perform

The Client may terminate the Contract if the Service Provider fails to perform the services, in accordance with the above terms and conditions, in spite of a 14-day notice given by the Client, without incurring any liability to the Service Provider. In the event of such termination, the amount due under the Contract shall be subject to equitable adjustment.

16. Termination Due to Integrity Violation

The Client may terminate this Contract, in whole or in part, if the Service Provider, in the judgment of the Client has engaged in integrity violations in accordance with Clause 5 [Fraud and Corruption], in

competing for or in executing this Contract.

17. Other Grounds for Termination

The Client may also terminate this Contract, in whole or in part, if the Service Provider becomes insolvent, bankrupt or gives the Client reasonable evidence of its inability to complete the Services as specified, or fails to correct any non-conformity in the Services or performs in bad faith by willfully not observing the terms and conditions of this Contract.

18. Force Majeure

The Service Provider shall not be liable for penalties or termination for default if and to the extent that its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.

- (a) For purposes of this Clause, "Force Majeure" means an event beyond the control of the Service Provider and not involving the Service Provider's fault or negligence and not foreseeable. Such events may include, but not restricted to, act of Client in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions, and freight embargoes.
- (b) If a Force Majeure situation arises, the Service Provider shall promptly notify the Client in writing of such condition and the cause thereof. Unless otherwise directed by the Client in writing, the Service Provider shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by Force Majeure event.

19. Accounts and Records

- (a) The Service Provider shall keep accurate and systematic accounts and records in respect of the Services in such form and detail as are customary in its profession and are sufficient to establish accurately that the costs have been duly incurred.
- (b) Notwithstanding anything to the contrary stated herein, the Service Provider shall maintain accounts and records, including original receipts, invoices and other supporting documents evidencing payments made by the Service Provider under this Contract, for the period of the Services and for a period no less than 3 years after the expiration or termination of this Contract.
- (c) The Service Provider shall permit ADB to inspect the accounts, records, and other documents relating to the submission of bids and contract performance of the Service Provider and to have them audited by auditors appointed by ADB.

20. Suspension of ADB Loan or Credit.

In the event that ADB suspends the Loan or Credit to the Client, from which part of the payments to the Service Provider are being made, the Client is obligated to notify the Service Provider, with copy to the Client's representative, of such suspension within 7 days of having received ADB's suspension notice.

21. Termination Notice Due to Non-payment

If the Service Provider has not received payments due within the 28 days as provided for in Clause 11 [Payment], the Service Provider may immediately issue a 14-day termination notice.

22. Liquidated damages : If the Supplier fails to deliver any or all of the Goods by the Date(s) of delivery or perform the Related Services within the period specified in the Contract, the Purchaser may without prejudice to all its other remedies under the Contract, deduct from the Contract Price, as liquidated damages, a sum equivalent to 0.5 % per week of the delivered price of the delayed Goods or unperformed Services for each week or part thereof of delay until actual delivery or performance, up to a maximum deduction of 10% of the contract value. Once the maximum is reached, the Purchaser may terminate the Contract pursuant to terms and condition of the contract.

The Particular conditions of contract

TERMS OF SERVICE (ToS) for Rental Vehicles for CPMO/PARBSP/MAIL's in below Regions

1. All the vehicles must be in good working condition with one spare wheel, basic repair tools, wheel chain and wheel replacement equipment in case of break down, hereafter referred to as the "Rented Vehicles".
2. The Rented Vehicles will be made available by the Contractor to the Client for ten hours per day. The vehicles will normally be used for Six (6) days per week, about 10 hours a day for the duration of the Contract to provide transport services for the Client-CPMO/PARBSP/MAIL throughout the all districts of the provinces(Khuaja Bahauddin, Yanqin Qala, Farhar, Shorab, Baharak, Khwaja Ghar, Chal, Dasht Qala, Center, & Estaq of **Takhar Province**, Imam Sahib, Dasht Archi, Khoja Ghar, Aqtipa, Chardara, Qalayzal, Ali Abad, Khan Abad, of **Kunduz Province**, and Yaftal Payeen, Shuhada, Kisham, Kohistan, Centar, Argo, Kishkan, Arghanjkhwa of **Badakhshan Province**) and regular visits to the surrounding areas where this area is hereafter referred to as the "Operational Area". However, it will be ensured that total usage will not exceed **2,700 KM/month**.
3. The responsibility for parking the Rented Vehicles over-night rests with the Contractor.
4. The Contractor will carry out and pay all the costs of the servicing of the Rented Vehicles at intervals according to the factory maintenance manual where servicing includes regular replacement of engine oil, replacement of air and fuel filters, checking and servicing of brakes, and all other servicing and maintenance works to ensure a thorough mechanical check guaranteeing that the Rented Vehicle is in good working order at that time. The Contractor shall also be responsible to bear all costs for all breaks down services and replacement of spare parts, if any.
5. The Contractor will maintain a detailed written record of all servicing of the Rented Vehicles. The record will be provided to the Client in the form of a brief report on the last day of each month together with the Request for Contract Payment
6. The Contractor will supply and pay for 100% of the costs of a replacement vehicle in case of break-down of the Rented Vehicle, and to provide this replacement vehicle for each day that a Rented Vehicle remains under repair and unavailable for the use of Client.
7. The Drivers nominated by the Contractor will be interviewed and tested for driving skills by the Client. Drivers that perform satisfactorily during interviews and driving skills tests will be approved by the Client. The Contractor will nominate new Drivers if they fail to perform to the Client's satisfaction.
8. The Contractor will be responsible for all wages and other remunerations associated with the Drivers and the driving services such as road tariffs, etc.
9. The Contractor will supply and pay for 100% of the costs of fuel, oil, spares, and other consumables used by the Rented Vehicles.
10. The Contractor will be responsible for 100% of costs associated with registering and insurance for the Rented Vehicle according to the laws of the Islamic Republic of Afghanistan.
11. The Contractor will be entirely responsible for any and all damages and losses incurred due to road accident, theft, or act of war or terrorism of the Rented Vehicle while the Rented Vehicle is used by the Client.
12. The Contractor will Invoice the Client on a monthly basis.
13. The vehicles must have government documents.
